FEATURE PREVIEW: Additional Validation

We will shortly be going live with an additional validation on the time stamp submitted by providers for *exposure datetimes* and *attendance datetimes*.

This will only affect Elekta and "Other" format returns. Once live, batches will be rejected if the *datetimes* supplied do not contain both a date and a time component. The minimum specificity accepted will be: *dd/mm/yyyy hh:mm:ss*.
